## 253. Reports from District and County Councillors

#### **Clir Janet Duncton**

Things are going well as normal with Children's Services and Adult Services and as ever a plea that if you know anyone interested in Fostering we need them.

A lot of our meetings recently have been about the coming devolution programme and I am happy to verbally tell you exactly what is happening and where we are with it.

Highways as ever have been busy and I was hoping to have some notes on the success stories that we have with highways at the moment but the briefing paper did not arrive. /4 However I can tell you what I learnt from a verbal briefing last week.

It is a good news story and of course nothing is perfect but huge improvements have been made.

Most of the reported potholes are getting attended to in ¾ days when they reach the 40mm depth. Jane will know that we had a very good quick result in Plaistow last week so long may this continue.

The other item I picked up on was clearing of gully's. This was a once in 4 years problem unless a problem arose but this has now been reduced to 2 years. I am sure you understand that we have many thousand to deal with across the County so this will be good.

Of course it's budget time and we have a County Council just for the budget next week. It will be a balanced budget with no cuts. We are of course waiting to see if Government is going to reimburse for the new NI tax that we will have to pay and this will take about 6 million from the budget. We have catered for this but still think we may get it back from Government.

I have no further news on Brewhurst Bridge I'm afraid although I have asked today but not as yet had a reply.

#### **Local Updates**

**Loxwood Shop** – This has been confirmed to be a Budgens and a licence was approved for the shop to sell alcohol until 11pm. This does not necessarily mean the shop will remain open until 11pm but it does mean that it gives it the best chance to be a viable business. The overwhelming message from the community is that they want a shop in Loxwood so it's important the council supports it to achieve that.

**Townfield** – Earliest it will come to the planning committee will be April. There is likely to be a period of further consultation following submission of further information from the applicant re water neutrality, land use plan and design and access.

The Foresters Arms, Kirdford—Reopening this month and delighted to see this community hub back in action and wish them the best in their venture.

**Fairhurst, Plaistow Road** – We were contacted about potential development without planning permission. CDC have confirmed this was not the case and the work is to remedy a fuel leak. The environmental agency went to review the situation on Thursday 30<sup>th</sup> January.

**Wisborough Green Street Naming –** We supported the Parish Council in overturning an officer proposal to create two street names on the Stable Field development which has 8 dwellings. We could not understand the need to create two street names on a small development site. Ultimately the officer agreed to the single name of Barnfield Shaw

**Neighbourhood Plans** – Parish Councils and community volunteers have started work on neighbourhood plans in several of our Parishes.

#### **CDC Wide Updates**

**Local Plan**— We have now received the post hearings letters from the inspectors. The letter is positive news for the local plan but there is still work to do, particularly on modifications requested by the inspectors and subsequent consultations. We are hopefully the local plan can be adopted by the council in late summer.

**Devolution and Local Government Reorganisation** – We are awaiting the government's response to West Sussex, East Sussex and Brighton and Hove's request to become a strategic Mayoral authority. We will continue to update as information becomes available.

**Petworth House Laser Show** - On the 15<sup>th</sup> February there will be an exciting Laser Show and illumination at Petworth house. The two performances accompanied by music of around twenty minutes will start at 5.30pm and 6.45pm. Petworth House will also be free to visit on the day between 10.30am and 3.30pm

Cllr Brooks reported that the planning officer had contacted him with regards to the usage of the pavilion, with a mind to put a condition on the application to cap the usage as set out in the Water Neutrality Report submitted by the Parish Council.

It was agreed that CIIr Brooks would contact the planning officer to see if the condition could be reworded to say that usage would be dependent on the storage of water held in the tank(s), and once the level reaches a critical level the pavilion would be closed until the tank(s) had been replenished by rain water.
