# 131. **Reports from District and County Councillors:**

Report from Cllr J Ransley

CDC Council meeting debated the A27 upgrade consultation response, and a lively day it was. I lobbied hard to ensure that CIL funding and other monies for infrastructure are spent on improvements in line with new development, this resulted in the CEO making it clear that there is a funding gap and that Council is working with partners to finds ways of filling that gap if at all possible.

I have spoken with the Planning Officer dealing with Plaistow Road and understand that they are awaiting further Viability report from the applicant and following receipt will arrange to meet with the Parish Council before progressing the committee report. I'd expect the matter therefo re will not go to committee before November. I'd be happy to enjoin the meeting if Council consider it beneficial

Crouchlands – I have sent further complaint to officers about the notable increase in HGV's going to and from the site from late and whether this is in contravention of its legal use status. In my view, the more the LPA's are kept advised on traffic volumes the better

Cllr Mrs J Duncton reported that the advertisement for extra Fire Fighters attracted over 700 applicants, 14 of which have been chosen and are being trained by WSCC. All Fire Fighters are now trained to use Fibulators through the Ambulance Service.

The WSCC Rangers are having their duties reduced, this will include the clearance of shrubbery around road signs. This news was not received gladly by the Council as it could cause Road Safety issues. (Cllr Mrs J Duncton left the meeting at 8.30pm)

### 132. Crouchlands Biogas: -

Crouchlands have applied for planning permission to buid a huge cow shed, which the Parish Council have objected to.

The planning enquiry regarding retrospective planning has been rescheduled yet again until April- July 2017.

The EA have prosecuted Crouchlands Farm for the pollution in the River Kird, and a small fine has been imposed, but this may not effect CBG.

CBG continue to operate as CDC/WSCC have not issued a stop notice.

# 133. Butts Common: -

A meeting has been arranged for 19/10/16 where all parties will attend, NT, SW, WSCC as well as Cllr Mrs L Nutting and the Clerk, hopefully we can agree a way forward.

# 134. Aircraft Noise: -

Part of the agreed actions following the Arrivals Review was to widen the swathe, but with no noticeable improvement, CAGNE are investigating.

LGW have applied to reduce costs for night landing slots, presumably to increase usage, this will obviously increase noise at night. Farnborough have applied for airspace changes that could affect LGW.
