187. **Apologies for Absence:** - Cllr Mrs J Robertson (unwell)

188. **Public Participation:** - One member of the public was present.

189. **Disclosures of Interest:** - To receive disclosures of personal and prejudicial interest from Councillors on matters considered at the meeting. – None to report.

190. **Approval of Meeting Minutes:** To resolve that the minutes from the Parish Council Meeting (19.03.18) and the Finance Meeting (09.04.18), be signed as a correct record. **Unanimously agreed** and duly signed.

191. Reports from District and County Councillors:

Cllr Mr J Ransley gave an update on the situation regarding the Plaistow Road Development. It has been 4 months since the Planning Committee at CDC had met and CDC are still waiting for CALA to return the signed S106. Until this is received there can be no further actions.

Cllr Mrs Janet Duncton reported that WSCC are looking at how they can better support children in care. Particularly the older children who are eligible to join apprenticeships. More money has been made available to help minors in care. WSCC are doing well to unblock beds in St Richards Hospital, Chichester. WSCC has received an extra 1.6M from government to deal with the potholes in the county which has enabled 3 extra teams to start work.

Cllr J D and Cllr JR left the meeting at 8pm.

192. Correspondence:

The contract for Grass Cutting was discussed and it was agreed to award the contract to JWS Contractors, Wisborough Green.

A thank you letter had been received from WGPC for the donation towards the upkeep of the Public Toilets in Wisborough Green.

The Clerk had received a response from Velco regarding the Cycle Race scheduled for September 2018, it confirmed that the route will not be travelling through the village.

An apologetic letter has been received from the Petanque Group regarding the vehicle damage to Butts Common. The Group Leader has made assurances that all members will be asked NOT to park on the green.

193. Chairman's Announcements:

Cllr Mrs AG reported on the following items:

Litter pick confirmed as May 8th – May 14th, posters to be put up around the village requesting help, all full rubbish bags to be left at the Village Hall for collection. Top Soil: it was agreed to increase the order to 3 dumpy bags for delivery first week of May.
